#### Risk Statement

- d) I accept responsibility for any injury, damage or loss to the extent caused by my own actions or omissions or actions or omissions of my child;
- e) the provision of a cadet leadership team, support boats and other officials and volunteers does not relieve me of my parental/guardianship responsibilities or my child of his/her responsibilities;
- f) the provision of support boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances;

## **Conditions of Use of Photography**

### **Participation Conditions**

- 1. All participants MUST be between the ages of 8 and 17 and be confident in the water.
- 2. All participants MUST wear the buoyancy aid provided.
- 3. Children under 16 must be accompanied by a parent or guardian at the beginning and end of the session. Parents/ guardians must also be contactable (for example by mobile phone) for the duration of the season.
- 4. Neither Leigh Sailing Club nor any of its officers or volunteers shall be liable in any way whatsoever in respect of loss or damage to property.
- 5. Leigh Sailing Club must be informed of any medical condition affecting the participant and/ or of any medication taken by the participant that could affect their taking part in sailing sessions in particular asthma, epilepsy and heart conditions. Leigh Sailing Club reserves the right to refuse participation on medical grounds.
- 6. Participation is on the understanding that any instructions or directions given by any cadet leader is to be observed. Participants are asked to respect the equipment and clothing available for cadet members use. Compensation will be sought from anyone deliberately causing damage to equipment.
- 7. Leigh Sailing Club reserves the right at all times to refuse or restrict the use of facilities. The right is also reserved to evict anyone who refuses to comply with the conditions as stipulated, or who behaves inappropriately or in any way causes damage or annoyance to any other persons.
- 8. Participants are to wear suitable clothing and footwear when going on a boat. Suitable footwear means flat soled shoes or trainers if not sailing boots. Cadets must bring a change of clothing if they do not own a wetsuit as sailing can be wet!
- 9. If any injuries are sustained or damage to valuables occurs, participants are to notify the club's cadet leaders immediately.

#### Conditions of Use of photography or video

In accordance with our child protection policy Leigh Sailing Club will not arrange for photographs, video or other images of other young people to be taken or published without the consent of the parents/guardians and children. We will abide by the conditions of use below. If you have any concerns about the way images are being used, you should inform our welfare officer immediately.

- 1. We will normally only identify a child by reference to the child's first name.
- 2. We will not use personal details or full names (ie first name and surname) of any child to accompany a still or video image on our website, newsletter, social media or any other electronic or printed publications unless they have won a trophy or award.
- 3. Care will be taken not to include personal information such as emails, phone numbers or street addresses in photographs or video in any electronic or publication by the club.
- 4. We may use group photos with general titles such as 'cadet sailing'.
- 5. We will only use images of children who are suitably dressed to reduce the risk of images being used inappropriately.
